

Win a **Tesla Model 3** Raffle

OFFICIAL RULES

The Quest Ministries Board of Directors (The Ministry), a California nonprofit organization and religious tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting the 2018 Tesla Model 3 Raffle to raise funds for its ongoing charitable activities and purposes. The rules (the "Rules") of the Raffle, as set forth below, govern the Raffle, award of prizes, and participation in the Raffle.

These Rules bind every person who buys or holds a Raffle ticket ("Ticket Holder"). By purchasing or holding a ticket, each Ticket Holder agrees (a) to be bound by these Rules and (b) that Quest Ministries, Inc. interpretation and application of these Rules is conclusive and final.

Tickets

Raffle tickets cost \$20.00 per ticket. No more than 10,000 tickets will be sold. Pursuant to Internal Revenue Service regulations, amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts and therefore do not qualify as deductible charitable donations.

Eligibility

To be eligible to purchase a ticket, a Ticket Holder must (a) be at least 18 years old at the time of purchase, (b) be a U.S. resident physically residing in the United States or District of Columbia, and (c) not be precluded by Applicable Law (as defined in the "Registration with the State of California and Applicable Law" section of these Rules) from holding or purchasing a ticket or participating in a raffle.

A person cannot be a Ticket Holder if such person is a person (a) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control of the Department of the Treasury (including those names on OFAC's Specially Designated and Blocked Persons List) or under any statute or executive order or (b) who is acting, directly or indirectly, for or on behalf of any such person. (c) Quest Ministries Board members and their immediate family members may not purchase a ticket and are not eligible to win a prize.

Quest Ministries reserves the right to require reasonable evidence of the eligibility of a Ticket Holder at any time and to void any ticket sold to a person who does not meet the eligibility requirements or who is precluded by applicable law from holding a ticket or participating in a raffle.

How to Purchase Tickets

Ticket Holders may purchase Raffle tickets either by calling, emailing, texting, mailing (USPS) or in person at any event or at our home office. At the time of purchase, Ticket Holders must provide their first name, last name, address, phone number or email. If they choose to purchase a ticket(s) by use of a credit card or debit care the Ticket Buyer must provide their credit card number, credit card security code, expiration date, and such other information as the Ministry may require. Ticket Holders may not purchase tickets online or directly through means support by any other method not approved by the Board of Directors as listed above. All entries must include payment by cash, personal check, debit or credit card.

Purchase Deadline: Saturday, October 20, 2018 at 1:30 p.m. Pacific Time (Lancaster, CA) or such earlier date as the maximum number (10,000) tickets is sold. All payments will be deposited upon receipt. The Ministry reserves the right to reject any entry form that it deems defective, illegible, ineligible, or submitted without "good funds."

In accordance with all State and Federal laws, raffle tickets will be printed and retained by the Ministry. All tickets sold will be entered into the drawing. Raffle ticket copies will be distributed to Ticket Holders via e-mail, through the U.S.P.S. or in person that will identify the unique ticket number(s). To win a prize, Ticket Holders do not need (a) to possess a hard copy of a Raffle ticket or a receipt in order to win and (b) do not need to be present at the drawing in order to win.

All Raffle ticket sales are final and non-refundable. No refunds are available except at the discretion of The Ministry. However, in the event the Raffle is cancelled with the approval of the Quest Ministry Board of Directors, all ticket purchases will be refunded. The Ministry assumes no responsibility for lost, late, misdirected, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

The Drawing

The Ministry will draw at random and determine the winning ticket under the supervision of The Ministry's Certified Game Manager(s) (as defined by the California Secretary of State rules). The drawing will be open to the public, though the winner need not be present to win.

The Drawing of the Prizes will occur at 2:00 p.m. on October 20, 2018, during the Quest Ministries, Inc. gathering located at the picnic area located at 44514 20th Street West, Lancaster, CA 93534.

At the Prize Drawing, the winning raffle ticket(s) shall be chosen by picking it from a raffle drum containing all tickets, thoroughly mixed. The Ticket Holder of the winning ticket(s) (the "Winners") shall be notified via e-mail and Certified U.S. Mail at the address provided by the Ticket Holder. The winning ticket numbers and names of the Winners shall also be placed on the Ministries' website within 48 hours after the drawing.

At the discretion of Board of Directors and subject to approval, the Ministry may extend or modify the Purchase Deadline and Prize Drawing date, time, and location. The Ministries Certified Game Manager(s) is the final authority in the event of any disputes regarding any of the drawings.

Odds of Winning

The odds of winning will depend on the number of tickets sold. The chance of winning the Grand Prize will vary based upon the number of tickets sold. If The Ministry sells all 10,000 tickets, then odds of winning the Grand Prize are 1 in 10,000. If The Ministry sells less than 10,000 tickets, then the odds of winning the Grand Prize will increase.

Grand Prize

Grand Prize: 2018 Tesla Model 3 automobile valued at \$52,700. Specifications include: Red Multi-Coat Paint, Extended-range 75 kWh battery package, 19-inch AMG twin 5-spoke wheels, Panorama Sunroof, Night Package (gloss black exterior accents); Interior – Black MB-Tex seats, Premium Package (KEYLESS-GO, Heated Front Seats, Harmon/Kardon LOGIC7® Surround Sound System, Sirius XM® Radio with free trial term, Blind Spot Assist, Rearview Camera), Convenience Package (Auto-dimming Mirrors, Garage Door Opener, Compass), and Smartphone Integration Package (Apple CarPlay®, Android Auto).

The Grand Prize WINNER IS SOLELY RESPONSIBLE FOR ANY AND ALL TAXES IMPOSED OR ASSESSED IN CONNECTION WITH THE GRAND PRIZE INCLUDING ALL FEDERAL, STATE OR LOCAL TAXES, AND ANY AND ALL LICENSE, TITLE AND REGISTRATION FEES ASSOCIATED WITH THE GRAND PRIZE, as well as insurance (proof of which must be shown prior to delivery) and pickup or delivery costs.

The Grand Prize will be offered to the winner in "as is" condition without warranty of any kind, express or implied (including existing mileage up to 2,000 miles). The Grand Prize is non-assignable and non-transferable. Winner must provide valid U.S. driver's license and evidence of insurance prior to delivery. Vehicle awarded may differ slightly from vehicle displayed in promotional materials.

The Ministry of Quest shall have no obligation to Winner to provide or enforce any warranty or other right offered by any third party in connection with the Grand Prize. Any warranty or other right that may be provided or offered by any third party in connection with the Grand Prize shall be between the Winner and any third party provider of the Grand Prize. THE MINISTRY MAKES NO WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE GRAND PRIZE, INCLUDING BUT NOT LIMITED TO ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Net Raffle Proceeds. As used herein, the term "Net Raffle Proceeds" means (a) the gross proceeds received by The Ministry and received from the sale of tickets in the Raffle less (b) all Raffle-related expenses as determined by the Board of Directors. The determination by The Ministry will be binding in all events other than a manifest error made by The Ministry in the computation of the revenues and expenses of the Raffle.

Additional Prizes awarded may differ slightly from ones displayed in the promotional materials. The Ministry shall have no obligation to the Winner to provide or enforce any warranty or other rights offered by any third party in connection with the Additional Prizes. Any warranty or other right that may be provided or offered by any third party in connection with the Additional Prizes shall be between the Winner and any third-party provider of the Additional Prizes. THE MINISTRY MAKES NO WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE ADDITIONAL PRIZES, INCLUDING BUT NOT LIMITED TO ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Rules Applicable to All Ticket Holders and Grand Prize Winner

The Ministry and its' agents will make reasonable efforts to notify the Winners using information provided on the winning entry tickets or forms. If a Winner does not contact The Ministry within thirty (30) days after the first initial contact notifying Winner of their winning, then The Ministry shall give notice to Winner by U.S. Postal Service certified mail, return receipt requested, at the address set forth in the information provided by the Ticket Holder. This notice shall state (a) the Grand Prize won, (b) a telephone number of a contact person at The office of Quest Ministries, (c) the time and location where the Grand Prize can be claimed, and (d) that if the Grand Prize has not been claimed within thirty (30) days after the date the notification is given, that The Ministry may, at its option, retain the Grand Prize.

The Ministry will not award the Grand Prize if the winner (a) was ineligible to purchase a ticket or otherwise enter the Raffle, (b) provided materially false or misleading information to The Ministry in connection with the purchase of a raffle ticket, or (c) if participating in this Raffle or receiving the Grand Prize is prohibited with respect to such person pursuant to these Rules or Applicable Law. No other Raffle ticket will be substituted for a winning Raffle ticket, and The Ministry will retain the Grand Prize. A Ticket Holder cannot assign or transfer his/her interest in a Raffle ticket or Grand Prize won by a winning Raffle ticket.

As a condition to being eligible to receive a prize, Winner must sign and deliver to The Ministry: (a) a sworn affidavit of eligibility under these Rules and Applicable Law and satisfactory proof that he/she is the person named on the winning entry; (b) a correct taxpayer identification number (e.g., social security number, individual taxpayer identification number, or employer identification number), (c) satisfactory proof that the purchaser of the ticket was an eligible Ticket Holder at the time the ticket was purchased; (d) a publicity release, and (e) such other matters as The Ministry may reasonably request, such as proof of identification and proof of address to determine authenticity of individual claiming the Grand Prize. If the holder of a winning ticket does not provide a correct taxpayer identification number or otherwise comply with Applicable Law or these Rules, then The Ministry may, at its option, disallow the award of the Grand Prize to such Ticket Holder and retain the Grand Prize.

The Ministry appreciates and respects each Ticket Holder's privacy. We will use personal information provided by a Ticket Holder to fulfill Raffle ticket orders, to contact Winners and to publicize the name of Winners. Notwithstanding the foregoing, each Ticket Holder agrees his/her name, likeness, voice and city of residence may be recorded by audio, video, or digital means and may be used in any print, audio or visual media without notice or compensation for any purpose, including related to this or any other Ministry Raffle, or promotional materials.

Each Ticket Holder (a) agrees The Ministry, its directors, officers, employees, agents, and representatives are not responsible for any injuries, losses, or damages of any kind arising in connection with, or as a result of, this Raffle and/or that person's failure to win or redeem the Grand Prize, or that person's award of, acceptance of, or use of, the Grand Prize or additional prize; and (b) releases and agrees to indemnify, defend, protect, and hold harmless The Ministry and its directors, officers, employees, agents, advertising agency, contractors, insurers, attorneys, accountants, and affiliated entities from and against all losses, damages, rights, claims, and actions of any kind arising in connection with, or as a result of, this Raffle and/or that person's failure to win or redeem the Grand Prize or additional prize, or that person's award of, acceptance of, or use of the Grand Prize or any additional prize, or that person's failure to comply with Applicable Law; and (c) represents and warrants to The Ministry that he/she has read and understands these Rules and agrees to be bound by these Rules and The Ministry's decisions, which are final. **TICKET HOLDER'S SOLE AND EXCLUSIVE REMEDY AGAINST THE MINISTRY SHALL BE LIMITED TO THE RETURN OF THE PURCHASE PRICE PAID FOR TICKET HOLDER'S RAFFLE TICKET(S).**

If there is a dispute of any kind regarding the award of the Grand Prize or the awarding of an additional prize, or the conduct of the Raffle, The Ministry and all persons purchasing or holding a ticket agree to arbitrate any and all disputes through binding arbitration in accordance with the rules of the American Arbitration Association then in effect and shall be governed by the United States Arbitration Act (9 U.S.C. §§ 1-16). By the purchase of a ticket, all persons purchasing or holding a ticket (a) submit themselves to the jurisdiction of the District Court of the City and County of Los Angeles, California and appoint the then Clerk, or acting Clerk, of said court as their Agent for the service of all process in connection with such proceedings and consent to the arbitration of disputes between them. The official records of The Ministry held in the Raffle database shall be deemed correct and final.

Based on the State of California and Applicable Law

This Raffle is being conducted in accordance with the Raffle laws of the State of California. The Raffle is subject to these Rules, the laws of the State of California, and Applicable Law. If there is a conflict between these Rules and the laws of the State of California, the laws of the State of California shall govern. The Ministry reserves the right to modify the Rules and/or impose additional conditions, procedures, and requirements as may be necessary or required for the Raffle and the award of the Grand Prize or additional prizes, hereunder to comply with the laws of the State of California and Applicable Law. This Raffle is void where prohibited by law. These rules are copyrighted proprietary materials and may not be copied, reproduced, or used in whole or part in any manner.
